

However, the future of dance education will involve transitioning from these quick, bite-sized formats to long-form educational videos. While short-form videos are effective at generating interest and engagement, long-form content allows for more detailed instruction and structured learning. By offering full-length tutorials, comprehensive dance classes, and professional choreography, platforms can provide students with the depth of knowledge necessary for mastering dance techniques. This shift will move dance education beyond viral trends and into a more sustainable, in-depth learning model.

Integrating long-term dance education plans with online learning: As the demand for flexible learning grows, combining long-term dance education plans with online platforms will be key to the future of dance education. The hybrid model of in-person and online learning offers the flexibility for students to learn at their own pace while still following a structured curriculum. Through live-streamed classes, on-demand tutorials, and virtual workshops, dance education can reach a broader audience, including those who may not have access to traditional dance schools. Additionally, partnerships with reputable dance institutions could offer students certification programs and professional development opportunities, making online dance education a legitimate and valuable career pathway.

# 7. Conclusion

In the age of short videos, dance education has experienced a significant transformation. Platforms like TikTok and Douyin have accelerated the spread of dance culture, making it more accessible and engaging to a wider audience. The role of short video platforms in promoting dance education is undeniable. They have created new opportunities for dance education by increasing its reach and breaking down barriers to entry for both learners and educators. Short video platforms make dance more visible and allow people to learn through viral challenges, tutorials, and creative expression.

However, as we observe the growth of internet-famous (net celebrity) dance and its widespread popularity, it becomes clear that there is a complementary relationship between net celebrity dances and professional dance education. While net celebrity dances emphasize entertainment and viral trends, professional dance education focuses on skill development and artistic expression. These two approaches can work together to elevate the overall landscape of dance education, with net celebrity dances drawing interest and professional education providing depth and mastery.

Given the rapid rise of short video platforms, it is crucial for dance education to actively explore education models that adapt to these platforms. By leveraging the interactive, dynamic features of short video platforms, educators can create engaging, flexible, and scalable learning experiences. This could involve short-form tutorials, live-streamed classes, or collaborative dance challenges that inspire both participation and progression.

Finally, the long-term goal of dance education should be to shift from an "entertainment-based" model to a more "professional" model, ensuring that while entertainment continues to be a key part of dance's appeal, education remains rooted in technical skill, artistry, and cultural value. The challenge for educators and institutions will be to strike a balance, combining entertainment with a focus on serious dance education, and pushing the boundaries of dance into a more formalized and professional future.
